Following my internship and research assistant positions, I was appointed to a long-term position through a competitive process. I undertook this work full-time from November 2020 until I commenced my DPhil studies in October 2023, at which point I reduced my hours to 0.2 FTE.

During this time, I have pioneered the GO Lab's work on formal relational contracting, leading to its establishment as a key work area of the Lab. I developed a practitioner guide to relational contracting in the public sector, which brings together a review of the academic literature and real-world practitioner insights to provide an accessible overview of the potential benefits, challenges and key considerations. I built on this co-authored work to produce an academic publication on managing risk in public contracts through a relational approach. I also organised the inaugural symposium of the Formal Relational Government Contracting Roundtable, and convened and presented in sessions on relational contracting at the Social Outcomes Conference 2022 and 2023. In addition, I undertook a research project on 25 years of attempts to better coordinate local public services in England, and explored the implications for models of accountability and central-local relations.

Alongside my research work, I am also involved in the extensive engagement work of the GO Lab. I am the Editor of the Oxford Government Outcomes Blog, alongside editing all of the Lab's major publications. I developed an editorial process to govern internal and external submissions to the Blog, and oversee submissions, editing and publication of articles. I have produced a weekly policy briefing, and presented research findings to a range of senior policymakers and practitioners.

During my internship and subsequent research assistant positions, I developed practical resources on outcomes-based contracts for social intervention programmes in a variety of contexts. I summarised existing GO Lab technical guidance to make it more accessible to practitioners, and produced outlines of key practical information from academic research on outcomes-based commissioning. I also produced a policy report into the UK Government's Kickstart employment scheme.
